# **Gyde Jensen MP**

Gyde Jensen was elected to the German Bundestag as the youngest female member in 2017. She is the chairwoman of the Committee on Human Rights and Humanitarian Aid and serves as the FDP parliamentary group's spokesperson on human rights and humanitarian aid.



### **Karoline Gil**

has a degree in European relations and socio-economic transformation and a longstanding experience in intercultural dialogue and the creation of multinational networks. For many years she initiates and moderates discussions with international experts.



# Marta Lempart

Marta Lempart is the initator and organizer of the All-Polish Women's Strike (Polish: Strajk Kobiet) a grassroots, nonpartisan movement spearheading the current mass protests against the near-total ban of abortions by the Polish Constitutional court. Apart from fighting for women's rights, Marta Lempart is also advocating for equal rights for members of Poland's LGBT community and for people with disabilities.

#### **ABOUT THE EVENT!**

At the beginning of this year, a near-total ban on abortions came into effect in Poland. The new regulation further tightened the nation's restrictive anti-abortion law, which was already among the strictest abortion laws in Europe. For months, thousands of people have been taking to the streets in several Polish cities to protest against the repressive abortion regulations and the ultra-conservative social policies of the ruling PiS party. The protests are led by courageous women like our guest speaker Marta Lempart, who stand up for women's sexual self-determination and reproductive health.

What is the state of women's rights and gender equality in Poland? What does the reactionary social policy of the ruling PiS party mean for Poland's relations with Germany? What measures can and must the EU take to protect common European values in Poland?

On the occasion of the 30th anniversary of the German-Polish Neighbourhood Treaty, the Friedrich Naumann Foundation for Freedom will discuss these important questions with Marta Lempart, co-initiator of the protest movement "All-Poland Women's Strike", and Gyde Jensen MP. Chairwoman of the Committee on Human Rights and Humanitarian Aid in the German Bundestag.

The event is part of the #femalechangemaker series, in which moderator Karoline Gil presents women from around the world who are fighting for freedom, human rights and democracy in their countries. The discussion will be held in English with simultaneous German translation.

With this online discussion, which is funded by the Federal Ministry for Economic Cooperation and Development (BMZ), the Friedrich Naumann Foundation contributes to making the UN's Agenda 2030 more known - especially regarding human rights and rule of law.

#### **Conditions of Participation**

The event is open to all citizens for participation. As the seminar is a publicly funded political education event, a commitment to participate in all parts of the program is a prerequisite for your registration.

Your registration can be made online or via a registration form and is binding for you. Unless otherwise stated in the description of the event, you will receive a binding confirmation of your registration no later than 10 days before the start of the event.

During the event, audio and video recordings may be made for documentation purposes. With your participation you agree that you may be depicted on such transmissions, video recordings or photographs, which may also be published.

In case of less than 10 registrations or force majeure, we reserve the right to cancel the event. We will inform you as soon as possible about a cancellation. Any payments made will be refunded immediately.

If the event is subject to a fee, the participation fee is due with the binding confirmation sent by us or the invoice.

If you have indicated cash payment at the event location as part of your registration, the amount will only be due at the start of the event.

If you have registered with a reduced participation fee, please bring suitable proof to the event or send it by e-mail to service@freiheit.org. The reduced participation fee applies to pupils, students (up to 30 years of age), trainees and the the unemployed.

The following applies to events lasting several days for which a fee is charged: You can cancel your registration free of charge up to 20 days before the start of the event.

If you cancel your registration up to 5 days before the start of the event, 50% of the conference fee will be charged as a cancellation fee. In case of later cancellation or in case of no-show, the full amount will be due, unless you name a substitute participant with your cancellation.

For one-day events for which a fee is charged, the following regulation applies, unless a different regulation is stated in the invitation: You can cancel your registration free of charge up to 3 days before the start of the event. In case of a later cancellation or in case of no-show, the entire full amount is due, unless you name a substitute participant with your cancellation.

Please pay the conference fee due as indicated on the registration. For some events we only accept cash payment for organizational reasons. Further claims are excluded. The place of jurisdiction is Potsdam.
